KILMALLOCK BOARD OF GUARDIANS.
(FROM OUR CORRESPONDENT).

The usual weekly meeting of this Board was held on Thursday, Mr John Carroll, V.C. presiding. The other Guardians present were—Messrs J Gubbins, M.D., J.P.; R Bayly, J.P.; J O'Sullivan, J.P.; J J O'Callaghan, James Lyons, T O'Donnell, J W Clery, James Pender, W Connolly, P D Clery, M Conway, D Condon, and B Flannery.

STATE OF THE HOUSE.
Remaining on Saturday, 24th ult, 484; admitted, 55; died, 1; born, 0; discharged, 61; remaining on 3rd inst, 476; corresponding period last year, 451.

FINANCE.
Lodged, £385; paid, £227; balance in favour of Guardians on current accounts, £124. Weekly cost outdoor relief, £72; general average cost 2s 11½d; balance against Guardians on labourers' accounts, £1,204.

Dr Sheedy, Kilmallock, applied for 6 guineas remuneration for discharging the duties of the workhouse and dispensary medical officers during their absence at the Assizes.

It was stated that he was acting only 3 days pro tem, and Dr Sheedy was allowed 3 guineas for that time.

In accordance with the usual notice of motion, Mr Connolly moved that Mr John Carroll, architect, be appointed to draw up specifications of the repairs required to be done to all the labourers' cottages up to the present, and to superintend the repairing of same at a remuneration of £30.

Mr John Ryan—Are not all the cottages done up?

Mr Coll (Clerk) said not. In Kilfinane, Glonbrohane, and other places they required to be repaired.

Mr Ryan—I was under the impression that all the cottages were cone-roofed and done up.

Mr Flaherty—It would be a great deal more to the point if a man were sent round to see that they are kept clean.

Mr James Lyons seconded Mr Connolly's proposition.

Mr Ryan proposed an amendment, fixing the remuneration at £20.

This was seconded.

Mr Flaherty suggested to leave it at £25.

Some Guardians were for having it go to a poll.

Mr O'Sullivan considered the amount, £30, rather small, as it would go in car hire.

It was agreed that the remuneration be £25.

THE HALF-YEARLY CONTRACTS.
For the supply of meat, the tender of Maurice O'Grady, of Kilmallock, was accepted at the following rates:—Beef off round, 4½d per lb; mutton, 4½d per lb; skins and neck of beef, 16lbs weight, 1½d per lb.

Mr W R Oliver, Buttevant Mills, was declared contractor for flour at £3 2s per ton; oatmeal, £11 15s per ton; Indian meal, £5 10s.

The tender of Mr Michael Morris, South Mall, Cork, was accepted at 20s per ton for Newport red ash screened coal, and 22s 6d per ton for Sydney coal. Messrs J A Harley tendered at 22s 4d per ton for both coals; and Messrs Scott Harley at 18s 9d for Newport red ash, and 22s for Sydney.

For the supply of candles, the tender of James O'Brien, Kilmallock, at 3½d per lb, was accepted; and the contract for eggs was declared at 6d per dozen.

For the supply of Guinness's XX Stout in half-barrels, James O'Brien, Kilmallock, was accepted at 23s 3d per half-barrel.

KILFINANE DISPENSARY.
Mr John Carroll, architect, reported that the above dispensary and medical officer's residence are finally completed, in accordance with the approved plans and specifications.

SANITARY ACTS.
Some notices under these Acts for the abatement of nuisances were sent in by Dr Cremin, Charleville, and the usual orders made thereon.

THE LABOURERS ACTS.
The accountant, Public Works office, wrote stating that the Bank of Ireland had been authorised to pay the Guardians the sum of £114 7s, an instalment of loan under the Labourers Acts. Another letter authorised the payment of £54, being another instalment of the loan.
The Board adjourned.

FUNERAL OF JUDGE PURCELL.
On Thursday morning the funeral of County Court Judge Purcell, Q.C. took place.

The remains were removed at nine o'clock from his late residence, 71 Harcourt-street, for interment in Mount Jerome Cemetery. The number of mourners was remarkably large and representative, including members of the Bench and several distinguished members of the legal profession, of which the deceased was so great an ornament, and also many of the best-known Dublin citizens. Indeed, the attendance at the funeral was a proof of the great esteem and affection with which Judge Purcell was regarded by all who had the pleasure of knowing him.
